ADMINISTRATIVE NOTES FOR SHAREHOLDERS AND PROXIES

59TH ANNUAL GENERAL MEETING ("AGM") OF PJ DEVELOPMENT HOLDINGS BERHAD ("COMPANY")

1. Date, Time, Broadcast Venue and Meeting Platform of AGM

The AGM of the Company will be held on a virtual basis via Remote Participation and Voting ("RPV") facilities. The details of the virtual AGM are as set out below:

Date : Wednesday, 17 April 2024

Time : 11:00 a.m.

Broadcast Venue : Main Auditorium, 11th Floor, Plaza OSK, Jalan Ampang, 50450

Kuala Lumpur, Wilayah Persekutuan

Meeting Platform : Securities Services e-Portal at https://sshsb.net.my/

Kindly be advised that the broadcast venue is strictly for the purpose of complying with Section 327(2) of the Companies Act 2016 and Clause 56 of the Company's Constitution, which require the Chairman to be present at the main venue of the AGM.

As the AGM will be held via RPV facilities in its entirety, **NO shareholder or proxy shall be physically present** at the broadcast venue on the day of the AGM.

2. Entitlement to Attend

In respect of deposited securities, only members whose names appear in the Record of Depositors as at 5 April 2024 shall be eligible, to attend, participate, speak and vote at the AGM.

3. Lodgement of Form of Proxy of AGM

If you are unable to attend the AGM via RPV facilities, you may appoint the Chairman of the AGM to vote on your behalf as per the voting instruction in the Form of Proxy. The instrument appointing a proxy and the power of attorney or other authority (if any), under which it is signed or a duly notarised certified copy of that power or authority, must be deposited not less than forty-eight (48) hours before the time for holding the AGM, i.e. latest by 11:00 a.m. on Monday, 15 April 2024 or any adjournment thereof through either one (1) of the following avenues:

(i) In Hardcopy Form of Proxy

(a) To be deposited at the office of the Poll Administrator, SS E Solutions Sdn. Bhd. at Level 7, Menara Milenium, Jalan Damanlela, Pusat Bandar Damansara, Damansara Heights, 50490 Kuala Lumpur, Wilayah Persekutuan.

(ii) By Electronic Form of Proxy

- (a) To be submitted electronically via Securities Services e-Portal at https://sshsb.net.my/. Please refer to the **Annexure A** for further details; or
- (b) To be submitted via fax at +603 2094 9940 or +603 2095 0292 or emailed to eservices@sshsb.com.my.

A proxy may but need not be a shareholder of the Company. There shall be no restriction as to the qualification of the proxy.

The lodging of the Form of Proxy does not preclude you from participating and voting at the AGM should you subsequently wish to do so, provided a notice of termination of proxy authority in writing is given to the Company before the commencement of the meeting and you have completed registration for the AGM via Securities Services e-Portal at https://sshsb.net.my/.

4. Voting Procedure

Pursuant to Clause 64 of the Constitution of the Company, the Chairman of the Meeting has the right to demand a poll vote for all resolutions as set out in the Notice of the 59th AGM.

The polling process shall be managed by SS E Solutions Sdn. Bhd., who will serve as the Poll Administrator to conduct the poll by electronic means. Independent scrutineers shall be appointed to verify and validate the results of the poll at the AGM.

5. Procedures for RPV

Kindly refer to **Annexure A** for information on RPV procedures to enable your remote participation in the AGM through live streaming and online remote voting.

6. Door Gifts

Kindly be advised that NO door gift will be provided for shareholders and/or proxy(ies) who attend the virtual AGM.

Securities Services e-Portal is an online platform that will allow both individual shareholders and body corporate shareholders through their appointed representatives, to -


- Submit proxy form electronically paperless submission

- Participate in meetings remotely via live streaming
- Vote online remotely on resolution(s) tabled at meetings (referred to as "e-Services").

All users are to read, agree and abide to all the Terms and Conditions of Use and Privacy Policy as required throughout the e-Portal.

BEFORE THE MEETING

(A) Sign up for a user account at Securities Services e-Portal

- Step 1 Visit https://sshsb.net.my/
- Step 2 Sign up for a user account
- Step 3 Wait for our notification email that will be sent within one (1) working day
- Step 4 Verify your user account within seven (7) days of the notification email and log in
- We require one (1) working day to process all user signups. If you do not have a user account with the e-Portal, you will need to sign up for a user account by the deadlines stipulated below.

Step 1 Check if you are attending as -

- Individual shareholder
- For body corporates, the appointed corporate / authorised representative has to upload the evidence of authority (e.g. Certificate of Appointment of Corporate Representative, Power of Attorney, letter of authority or other documents proving authority). All documents that are not in English or Bahasa Malaysia have to be accompanied by a certified translation in English in 1 file. The original evidence of authority and translation thereof, if required, have to be submitted at the Poll Administrator's office, SS E Solutions Sdn. Step 2 Submit your registration.

- All shareholders must register for remote participation at the meeting and are highly encouraged to register as early as
 possible and before the eLive access date and time [see (D) below] in order to ensure timely access to the meeting. Access
 shall be granted only to eligible shareholders in accordance with the General Meeting Record of Depositors as at 5 April
 2024.
- A copy of your e-Registration for remote participation can be accessed via My Records (refer to the left navigation panel).
- Your registration will apply to **all the CDS account(s)** of each individual shareholder / body corporate shareholder that you represent. If you are both an individual shareholder and representative of body corporate(s), you need to register as an individual and also as a representative for each body corporate.
- As the meeting will be conducted on a virtual basis, we highly encourage all shareholders to remotely participate and vote at the meeting, failing which, please appoint the Chairman of the meeting as proxy or your own proxy(ies) to represent you.

- Step 1 Check if you are submitting the proxy form as -
 - Individual shareholder
 - For body corporates, the appointed corporate / authorised representative is to upload the evidence of authority (e.g. Certificate of Appointment of Corporate Representative, Power of Attorney, letter of authority or other documents proving authority). All documents that are not in English or Bahasa Malaysia have to be accompanied by a certified translation in English in 1 file. The original evidence of authority and translation thereof, if required, have to be submitted to the Poll Administrator's office, SS E Solutions Sdn. Bhd. at Level 7, Menara Milenium, Jalan Damanlela, Pusat Bandar Damansara, Damansara Heights, 50490 Kuala Lumpur, Wilayah Persekutuan for verification before the proxy form submission closing date and time above.
- Step 2 Enter your CDS account number or the body corporate's CDS account number. Then enter the information of your proxy(ies) and the proportion of your securities to be represented by your proxy(ies).
 - You may appoint the Chairman of the meeting as your proxy if you are not able to participate remotely.
- Step 3 Proceed to indicate how your votes are to be casted against each resolution.
- Step 4 Review and confirm your proxy form details before submission.
- A copy of your submitted e-Proxy Form can be accessed via My Records (refer to the left navigation panel).
- You need to submit your e-Proxy Form for every CDS account(s) you have or represent.

PROXIES

All appointed proxies need not register for remote participation under (B) above but if they are not registered Users of the e-Portal, they will need to sign up as users of the e-Portal under (A) above by 11 April 2024. PLEASE NOTIFY YOUR PROXY(IES) ACCORDINGLY. Upon processing the proxy forms, we will grant the proxy access to remote participation at the meeting to which he/she is appointed for instead of the shareholder, provided the proxy must be a registered user of the e-Portal, failing which, the proxy will not be able to participate at the meeting as the meeting will be conducted on a virtual basis.

Do take note that the quality of the live streaming is dependent on the stability of the internet connection at the location of the user.

- If you are already accessing the Live Stream Meeting, click Proceed to Vote under the live stream player.

- If you are not accessing from the Live Stream Meeting and have just logged in to the e-Portal, look for <u>PJ Development</u> <u>Holdings Berhad</u> under Company Name and <u>59th AGM on 17 April 2024 at 11:00 a.m. Remote Voting</u> under Event and click ">" to remotely cast and submit the votes online for the resolutions tabled at the meeting.

- Step 1 Cast your votes by clicking on the radio buttons against each resolution.
- Step 2 Review your casted votes and confirm and submit the votes.
- The access to eVoting will open on the abovementioned date and time.
- Your votes casted will apply throughout <u>all</u> the CDS accounts you represent as an individual shareholder, corporate / authorised representative and proxy. Where you are attending as a proxy, and the shareholder who appointed you has indicated how the votes are to be casted, we will take the shareholder's indicated votes in the proxy form.
- The access to eVoting will close as directed by the Chairman of the meeting.
